## **Privacy Policy**

### **Definitions and interpretation**

### DATA

### COOKIES

A small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

### DATA PROTECTION LAWS

  - a. The singular includes the plural and vice versa;

b. References to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of the privacy policy;

c. A reference to a person includes firms, companies, government entities, trusts and partnerships;

- d. "Including" is understood to mean "including without limitation";
- e. Reference to any statutory provision includes any modification or amendment of it;
- f. The headings and sub-headings do not form part of this privacy policy.

### Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Camvac Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Camvac Limited is the "data controller". This means that Camvac Limited determines the purpose for which, and the manner in which, your Data is processed.

### **Data Collected**

- 5. We may collect the following Data, which includes personal Data, from you:
  - a. Name;

  - c. IP address (automatically collected);

  - in each case, in accordance with this privacy policy.

### How we collect Data

## Data that is given to us by you

- 7. Camvac Limited will collect your Data in a number of ways, for example:
  - a. When you contact us through the Website, by telephone, post, e-mail or through any other means;

in each case, in accordance with this privacy policy.

## Data that is collected automatically

8. To the extent that you access the Website, we will collect your Data automatically, for example:

a. We automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and included your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

b. We will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

- in each case, in accordance with this privacy policy
- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your Rights" below).
- 11. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft opt-in:

a. Soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.

b. For other types of e-marketing, we are required to obtain your explicit consent that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.

## **Data Retention**

- 17. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

### **Your Rights**

18. You have the following rights in relation to your Data:

If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." c. Right to erase – the right to request that we delete or remove your Data from our systems.

d. Right to restrict our use of your Data – the right to "block" us from using your Data or limit the way in which we can use it.

e. Right to data portability – the right to request that we move, copy or transfer your Data. f. Right to object – the right to object to our use of your Data including where we use it for our legitimate interests.

Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
- 24. We may also disclose Data to a prospective purchaser of our business or any part of it.
- 25. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

  - Strictly necessary cookies
